Sources of Reliable Information

1. National Institute of Statistics or Instituto Brasileiro de Geografia e Estatística (IBGE, n.d.): IBGE is a public institution responsible for collecting, processing, and providing official data on the Brazilian population. Its information is reliable and can be used to analyze the country's economic, social, environmental, and demographic situation to support decision-making and planning at all levels of government. 6. World Bank: The World Bank is a development institution that provides financial resources and technical assistance to countries to reduce poverty and improve living standards. 7. United Nations Development Program (UNDP): The UNDP is responsible for promoting sustainable development worldwide.
