A study by Whitman suggests that by eliminating clothing differences between students, it is thought that there will be less external pressure to conform to certain social groups, as well as fewer opportunities for students to express themselves through fashion. This can be backed up by personal experiences attending schools with uniforms as opposed to those without. In schools where a uniform was enforced; there was far less emphasis placed on clothes than in those which did not require them. Uniforms help to

create an atmosphere of equality among students regardless of economic background, reducing pressure for some students to keep up with designer trends.

Popular designer clothes adored by many students at Virginia Beach public school can often be out of reach for single parents or lower-income families due to their high price tags. An article by Ahrens and Siegel notes that school uniforms can reduce the financial strain on families who may not be able to afford a wide variety of clothing options for their children. By providing standardized clothing options at lower costs than designer apparel, schools can help those with limited budgets provide their children with the clothing they need to attend classes without worrying about how much money it will cost them. In this way, enforcing a dress code in the form of uniforms could help to reduce the financial strain for these families. Uniforms would also eliminate the need for parents to buy multiple outfits every season, further saving them money.

One argument against uniforms is that they will stifle students' individuality and freedom of expression. However, introducing uniforms into schools will not prevent them from expressing their personality through hobbies and interests instead of focusing on superficial factors such as clothes; more attention can be placed on what truly matters. An article by Knipp and Stevenson argues that strictly enforced uniform policies, such as those found in many charter schools, prevent students from expressing their individual personalities through their clothing choices, including hobbies and interests. Rigid dress code policies reduce opportunities for self-expression while simultaneously creating a homogenous learning environment where all students appear similar. Moreover, too much individuality is precisely the problem with society today. Therefore, more focus is needed to establish a sense of community and belonging, which can be done with uniforms in place.

In conclusion, the public schools in Virginia Beach need to adopt a new dress code policy that would make uniforms mandatory for each student due to the numerous benefits it provides to both parents and students alike.
