Licensure/Credentialing Plan

Required Licensure/Credentialing

General Psychology is the study of human behavior and mental processes. Psychologists working in this field may work in a variety of settings, including private practices, hospitals, clinics, and schools. Although licensure requirements vary by state, most states require psychologists to have a doctoral degree in psychology from an accredited program. In addition, psychologists must complete a supervised internship and pass a national exam before they can be licensed to practice. Some psychologists may also choose to pursue additional credentials, such as becoming a Board Certified Behavior Analyst or a Registered Play Therapist. By meeting these professional standards, psychologists are able to provide high-quality care to their clients (Valsiner, 2021).

Additionally, at the doctoral level, licensure and credentialing requirements vary depending on the state in which one practices. In general, however, licensure is required in order to perform psychological assessments and provide therapy to patients. There are a number of different credentialing organizations that offer certification in various areas of psychology, such as clinical psychology, counseling psychology, and school psychology. Doctoral-level psychologists must also complete an internship and postdoctoral residency in order to be eligible for licensure (Silberbogen et al., 2018). In addition, most states require that psychologists take a continuing education course every few years in order to maintain their license (Abacan et al., 2019). Consequently, those who wish to practice psychology at the doctoral level must be prepared to meet a number of requirements in terms of education and training as counsellors

typically have a doctorate in psychology, and they use their training to help people with mental health issues, or to assess and treat mental health disorders..

Furthermore, in the United States, there is no single governing body that oversees licensure and/or credentialing for general psychology professionals. Instead, psychologists are regulated by a patchwork of state-level boards and organizations (Trebilcock, 2022). The American Psychological Association (APA) is the largest professional organization for psychologists in the country, and it sets ethical standards for the profession. However, the APA does not have any direct authority over individual psychologists. Instead, each state has its own licensing board that sets standards for practicing psychology within that state. Some states also have specialty boards that obscure credentials for specific areas of practice, such as clinical or counseling psychology (Trebilcock, 2022). Thus, specific information can be acquired as per the target state's guidelines.

Steps and Requirements

The requirements for licensure and credentialing in the field of psychology vary from state to state. In most states, a person must have a doctorate in psychology from an accredited program and pass a national exam in order to be licensed as a psychologist. Some states also require that psychologists complete an internship or postdoctoral fellowship. In addition, many states require continuing education in order to maintain a license. At the national level, psychologists can also become credentialed through the American Board of Professional Psychology (ABPP) (Abacan et al., 2019). To become credentialed through the ABPP, psychologists must have a doctorate in psychology, complete an approved internship, and pass a comprehensive written examination.

Additional Requirements

Most states require psychologists to be licensed in order to practice. However, there are a few additional areas that may be required for licensure that are not typically addressed through a master's degree plan. For example, many states require psychologists to complete a certain number of hours of continuing education in order to renew their licenses. Additionally, some states have specific requirements concerning the supervision of internships or postdoctoral training. As a result, it is important to be aware of the specific requirements for licensure in your state before beginning your graduate studies.
